Purpose

The Tunica-Biloxi Tribe of Louisiana seeks a qualified Lead Tribal Prosecutor to support the Tribal Court and collaborate with Tribal agencies in prosecuting criminal, juvenile, and civil matters within Tribal jurisdiction. The selected candidate will provide legal expertise to uphold Tribal interests and advance the Tribal justice system.

Scope of Work

The Lead Tribal Prosecutor will:

- 1. Prosecute criminal, juvenile, and civil offenses, including but not limited to domestic violence, child abuse, neglect, traffic violations, and status offenses within Tribal jurisdiction.
- 2. Represent the Tribe in Indian Child Welfare Act (ICWA) proceedings.
- 3. Provide legal advice to Tribal agencies, including Police, Social Services, and Housing Authority, on case preparation and legal documentation.
- 4. Draft legal pleadings, motions, and orders.
- 5. Refer cases to federal or state authorities as appropriate.
- 6. Develop and refine the Tribal justice system and assist with code development.
- 7. Train Tribal agencies on legal and victim-related issues.
- 8. Handle appeals from Tribal Court decisions.

Submission Requirements

Applicants must submit the following:

- 1. Cover Letter: Detailing your interest in the position and relevant qualifications.
- 2. **Resume/Curriculum Vitae (CV)**: Highlighting relevant experience, particularly in Indian law and criminal litigation.

- Bar admission in the State of Louisiana.

Must demonstrate at least three years' experience in the practice of law, preferably criminal litigation, juvenile, and civil matters.
